FULL OFFICIAL RULES

Hilton Tokyo Bay Hawaiian Promotion Instagram Campaign

ELIGIBILITY:

Only legal residents of **Japan**, who are 18 years of age or older at the time of entry are eligible to enter. Not open to employees, officers or directors, or to members of the immediate family or household (whether related or not) of any employees, officers, or directors of Tokyo Bay Hilton Co., Ltd., trading as Hilton Tokyo Bay (“**Hilton Tokyo Bay**”) and Hilton Hawaiian Village Lessee, LLC, trading as Hilton Hawaiian Village Waikiki Beach Resort (together with Hilton Tokyo Bay, collectively referred to as “**Sponsor**”), or any of their respective parents, subsidiaries, affiliates, franchisees, or any advertising, promotion or other agencies or suppliers involved in this Campaign (collectively, the “**Campaign Entities**”).
